

These personal financial hardships were a direct result of acts of nature, natural disasters, accidents and medical conditions including such things as: home fires, cancer treatments, accidents and leukemia.**

**Community Improvement Projects: During 2014 our donors provided \$36,514 which Red Basket used to make 26 grants to local communities to help improve public and private facilities in order to make the community a better place. Examples of grant purposes ranged from upgrading an animal control facility, supporting an organization that raises awareness for child abuse while providing support and encouragement for survivors and helping provide equipment and supplies to a free medical clinic.**
