Financial Hardship Assistance: During 2015 our donors have provided \$682,327 which Red Basket used as direct assistance to 211 recipients to help them achieve independence from financial burden. These personal financial hardships were a direct result of acts of nature, natural disasters, accidents and medical conditions including such things as: home fires, cancer treatments, accidents and leukemia.

Community Improvement Projects: During 2015 our donors provided \$69,853 which Red Basket used to make 74 grants to local communities to help improve public and private facilities in order to make the community a better place. Examples of grant purposes ranged from supporting food bank programs, restoring community centers, starting a recycling program and making improvements to a therapeutic horseback riding facility.
